ENF DONOR RECOGNITION

The Elks National Foundation is committed to honoring donors who uphold the Elks' tradition of philanthropy. Each recognition program and giving level is specially designed to thank and recognize donors for their support of the ENF's charitable mission. All recognition pieces are made in the U.S.A.

► The **Cumulative Recognition Program** recognizes donors' contributions over their lifetimes. Every gift a donor makes to the ENF counts toward his or her cumulative recognition level.

► The **Foundation Fellowship**, the ENF's annual giving program, recognizes donations during the fiscal year. Each gift a donor makes to the ENF within a fiscal year counts toward his or her annual giving level. This program restarts on April 1 of every year.

► The **ENF Fidelity Club** recognizes giving via automatic, regularly scheduled payments. Eligible donors have a monthly or quarterly payment deducted by credit card or direct debit, or donate regularly through their employer via payroll deduction or the Combined Federal Campaign.

► The **ENF Loyalty Club** recognizes individuals who have donated to the ENF annually for the past 10 or more consecutive fiscal years.

► The **John F. Malley Society**—named for the man who championed the idea of the Elks National Foundation—recognizes individuals who plan a gift to the ENF. A planned gift is most often a bequest, but can also be a gift of appreciated stock, gift of life insurance, or other life-income gift.
