## PAYROLL DEDUCTION PLANS

Setting up payroll deductions through your employer is an easy way to contribute regularly to the ENF. When you sign up for payroll deductions, a predetermined dollar amount will be deducted from each paycheck and earmarked for the ENF. Here's how to get started:

### SUPPORT THE ENF WHILE YOU WORK

- ▶ Check with your employer's HR office to find out if your company has a payroll deduction program.
- ▶ Complete any forms required by your employer, who will be responsible for sending your contributions to the ENF. Your full name and address should be included on checks that are mailed to us. Ask to also include your Lodge number on checks, if possible.

### COMBINED FEDERAL CAMPAIGN FOR GOVERNMENT EMPLOYEES

- ▶ **Government employees** may participate in their own payroll deduction program: the Combined Federal Campaign. The CFC registration period is September 1 to December 15. Choose the ENF (**CFC #12233**) on the CFC form, and check the box to release your giving information to the ENF.
- ▶ Contact the ENF directly with your pledge information so you and your Lodge get credit for your donations. Email [enf@elks.org](mailto:enf@elks.org) or call **773/755-4728**.

## MATCHING GIFTS DOUBLE YOUR IMPACT

Companies across the country often match financial donations or volunteer service hours from employees, spouses and retirees. Participating in your company's matching gift program is an easy way for you to double your donation to the Elks National Foundation. Here's how:

- ▶ Confirm that your employer participates in the matching gift program by visiting [www.matchinggifts.com/elks](http://www.matchinggifts.com/elks) or by contacting your Human Resources department.
- ▶ Check whether your company also matches volunteer service hours with financial contributions—and get rewarded for your Lodge work in your community.
- ▶ Fill out the matching gift form provided by your current employer (or former employer, if you're retired and eligible to participate).
- ▶ Submit your completed form to the ENF, and we will handle the rest.

If you've already donated to the ENF this year, contact your employer: Many companies match donations for up to a year, so you can still double your donation.
