- 4. Nanci Concerned that many members have been asking why the membership renewal checks have not been deposited, some are from January. Jerry said he decided to hold off depositing checks until he had the new card system was installed and working. Nanci said that this should not have prevented the checks from being deposited. - 5. Steve Asked why some of the membership payments are being deposited into the general fund and not the pre-paid fund. (The pre-paid fund should contain all the money from membership renewal payments so that it can be distributed to the general fund monthly) Jeff asked if the pre-paid account contained any funds. The bookkeeper will need to calculate how much money needs to be transferred to the pre-paid account. WIP

Chris suggested we research the By-Laws and revisit at next meeting. John C. suggested we post the RV rules behind the bar to avoid confusion. **WIP**
