I hear many complaints about our Lodge, the management, bartenders, wait staff, etc. One of the things I hear are comments about not being served at the bar. Arizona Liquor Laws require our bartenders to know when to, or not to serve an individual alcoholic beverages. When the bartender says they cannot serve you another beverage, it is to protect our Lodge and the person requesting the beverage. Always remember, the Lodge has the "Right to Refuse Service to Anyone", and the Bartender IS IN CHARGE of the bar.

I have also heard complaints from several people about the Lodge and membership cards. In particular the cards that are issued to Widows of Elk Members who have passed. Elks Lodge #2399 has for many years issued Widows Cards to the Widows, this is something that the Lodge has done for free as a courtesy to Widows. The only thing this card does is give access to the social quarters of the Lodge to include the Bar, Restaurant and special events. Grand Lodge does not require any Lodge to issue Widows cards. As I mentioned previously, this is a courtesy that we extend. It is expected that those Widows who do use the social quarters will not abuse the use of these cards as it may result in the loss of their card and the use of the Lodge. Grand Lodge requires that guests may only be brought into the Lodge three (3) times (unless they are family). Basically, if a Widow were to lose her card she would not be able to come into the Lodge, even as a guest, until she joined the Elks.

I apologize for rambling, but felt that some of these things needed to be brought into the light and the open. I hope that this will help all to remember their obligation and help foster good feelings towards all. The Officer's of the Lodge were elected by you the members, and we strive to do what is best for the Lodge. We have elections every year, and if you think there needs to be changes made, step up and run for one of the positions available.

I look forward to seeing you all around the Lodge.

**GRANT ACTIVITY 2024-2025**

Our Lodge has been actively participatin in the Elks National Foundation (ENF) Community Investments Program (CIP) for a number of years. There are two types of grants: Competitive and Non-Competitive.

The Freedom Grant - is Competitive and ENF awards only 300 Lodges with funding. Our grant started six years ago with the first Lake Havasu City, Stand Down. This is an event that brings services together for Veterans. Our Lodge does the food for the entire day and creates emergency backpacks for Veterans in need. The backpacks contents are funded with the grant funds of \$1,000.

The Beacon, Spotlight and Gratitude grants are all money that is guaranteed by ENF to receive these funds, you must have a project with a community need.

This year’s Beacon Grant is once again a donation to the Parks and Recreation for free and scaled tuition for the after schools programs. This is an ongoing, yearly donation supported by all the vists Drug Awareness and Youth Activities volunteers complete.

The Spotlight Grant is a focus on hunger this year, so our Lodge will once again collect cake and frosting for Thanksgiving and Christmas to accompany this \$2,000 donation to Meals on Wheels.

The Gratitude Grant funds of \$3,000 will help support Teen Break by renting the Gaming Trailer for the three day event where Youth Activities and Drug Awareness volunteer.

Grants are Lodge projects and I’m just the writer. I take an idea for a project, develop a goal and objective, and create Elk involvement. Each grant require writing, administration and evaluations. This year, we will give away \$10,000 to charity which is the very best of my job as Grant Administrator.

**PRIVACY AND SOCIAL MEDIA POLICY 9**

**FACEBOOK, TWITTER AND OTHER SOCIAL MEDIA ACCOUNTS**

Like E-mail accounts, Facebook, Twitter and other Social Media accounts create a permanent record even after materials are deleted. Courts are increasingly allowing for the discovery of materials posted on such accounts as evidence in cases relating to discrimination, defamation of character and other similar civil legal proceedings that can result in heavy financial penalties. They also reach an extremely broad audience, and each reader has his or her own standards regarding whether the line of offensiveness has been crossed, so use the utmost caution and discretion when posting. Liquor control commissions, Gaming Commissions and taxing authorities are known to prowl these social media accounts of fraternal groups looking for violations. Above all, social media outlets should never be used to discuss confidential matter of your Lodge or the Order, or to air personal grievances against fellow Members of the Officers of your Lodge or Members of other Elk entities. This is a violation of your obligation to never disclose the confidential matters of the Order and to protect the good names of our Members and their families.

**Personal Accounts:**

1. Never post any confidential matters of the Elks in general or your Lodge in particular, including without limitation posting on a friend’s Facebook page an announcement of confidential discussions or disputes that took place at a Lodge meeting.
2. Do not advertise a fund raiser that includes any personal information regarding the intended beneficiary of the fund raiser without his or her specific written permission.
3. Never post an event that involves gambling of any type (including raffles) unless you have a special license issued by the state to conduct the event.
4. Never post an event as being “open to the public” where alcohol is being served unless you are licensed to sell alcohol to the general public.
5. Do not advertise your status as a Member of the Elks in a manner designed to support a business or political candidate or issue.
6. Do not insult any Member or engage in a war of words against a Member on any social media outlet. It could result in possible charges for conduct unbecoming an Elk, and create a negative image of the Elks in general.
7. Feel free to post how much you enjoyed an event at the Elks or about your positive, non-confidential, experiences as an Elk. Be proud of who we are and what we stand for!
