

Message form the Exalted Ruler

What is going on with the building? That is the #1 question I hear about our Greater Pine Island Lodge #2781. Here is an update: we're waiting on getting the permit. It's the same answer you have heard now for the past year.

To getting to specifics I will do my best to summarize all the work that is happening behind the scenes. Recently our plan was submitted by an engineer that will remain nameless. The plan showed that our building

capacity for people would not exceed the 200 person limit. Anything above that requires us to install a fire suppression system (sprinklers). This is a cost that would break the bank for us in meeting our goal of paying for the new building with no debt.

We have had much frustration with this engineer in doing work that was not acceptable and in a very long and unacceptable timeframe. In the last two weeks, the head engineer that had been assigned to our project, the nameless engineer replaced this person after much frustration on our part.

This most recent plan was submitted before the unnamed engineer was replaced and once again had errors. Even though it said it showed occupancy for less than 200 people, when the reviewers did the math based on the ratios allowed in the various rooms (e.g. different ratios for the dining room than the offices), it showed we exceeded 200 people.

Simon Gonzalez, our builder, quickly responded to the issue and worked with the architect to make the necessary adjustments to bring us back to conformity to keep the occupancy under 200 people and re-submitted the drawings this week. Today he spoke with the head reviewer who requested Simon send the revised drawings to him (even though this had already been done a few days ago). Simon sent the revised plans to him again as he had cleared his inbox and said he did not notice them.

Simon requested to the head reviewer that we not start at the beginning of the process since the other plans had been submitted two weeks earlier. Why is this important? Because when you start over, the plans have to go through all the reviewers again in case the changes affected their individual permit. For example, the plumbing reviewer has to be assured the changes did not affect the plumbing so he now has to again sign off on the plumbing permit. Each subreviewer has to now go through the approval process for their area of expertise. The county is supposed to take the plans and have an answer in 4 weeks but it has been typically taking 7 weeks. If we can get the credit for the two weeks, it reduces the timeframe for review.

Exalted Rulers Message Continued:

Another example of part of our delays is the fire permit was approved three different times. (Why three? Because we have had our plans submitted and sent back that many times). The person who had approved the fire permit no longer works for Lee County and a new person has taken his place. She has been adamant that we put in a fire suppression system and will not approve the fire permit like the other person did. She did say if our local fire chief gave the OK to approve the fire permit, then she would have to approve it. Our local fire chief said if it is in compliance (under 200 person occupancy), then it is not necessary for him to approve it; it was up to the reviewer to approve it. He only can approve something if it is out of compliance and needs a variance (which the fire department has a standing policy they will not do).

This summarizes some of the activity from the past 10 days. There is much more. We have been running into an inconsistent process and an engineer that was not doing professional work. Our builder is confident in our new engineer. Now we are at the mercy of the county reviews and inconsistent set up standards.

Ben Madey, who has diligently represented our lodge, and our building committee under the direction of Bob Hoogstra have worked very hard to get our permits approved. Simon Gonzalaz, our builder, has also worked very hard to personally go to the county office and visit with the reviewers. Between Ben and Simon hundreds of calls and texts have been shared.

What is next? We are waiting to see what the head reviewer will do with this latest submission of our plans. Will we go to the "end of the line" or will we be allowed to be a priority so we can complete the permitting process and break ground and get our new building constructed?

Our new building will be an Insulated Concrete Foam building rated to withstand winds up to 200 mph. It will be worth the wait and will be a real asset to our Pine Island community. Thank you all for hanging in there with your membership and for your patience. This is not a pleasant experience for any of us but we are not going anywhere and we will persevere.

The Elk colors are Royal Purple and White, a combination deriving its origin from the history of the Clergy, Nobility and the People. Throughout Europe, the Orient and in Rome the symbolism of colors was associated with severity of laws and customs. Each color in each pattern was identified religious, or political, and to change or alter it was a crime of rebellion, a desertion of principles, party or cause.

White denotes purity and absolute truth. When combined with Royal Purple it signifies the love of truth and the highest degree of virtue. Purple is the badge of Kingship, the color for the robes of Emperors and High Priests, and signifies highest favor. Blending of White and Royal Purple indicates the favor of the people, which bespeaks the status of Elkdom.



- 2024-01—To remove the word indoctrination, which has negative connotations linked to forced acceptance of certain values or beliefs and amend it to the term orientation, which is a familiarization with the organization's principles and beliefs. 2,164 YES, 291 NO. PASSED.
- 2024-02—1) To move the control of the assets from the Grand Exalted Ruler's appointed Defunct Lodge Trustees to that of the State Sponsor(s). 2) Lodges and State Associations are both 501(c)(8)s. This change will allow funds to be given to State Associations without placing a restriction on their use if so deemed by the State Sponsor(s). 2,203 YES, 249 NO. PASSED.
- 2024-03—To remove the word indoctrination, which has a negative connotation linked to forced acceptance of certain values of beliefs and amend it to the term orientation, which is a familiarization with the organization's principles and beliefs. *This Resolution is dependent upon the passage of Resolution 2024-01.* 2,183 YES, 275 NO. - **2024-07**—To allow a Lodge to satisfy the bond requirement for the Lodge Treasurer through an outside insurance company. *This Resolution is dependent upon the passage of Resolution 2024-05.* **1,079 YES, 1,379 NO. FAILED**.
- 2024-08—To remove the requirement for the Lodge Treasurer to attend all District Deputy Clinics. 1,577 YES, 869 NO. PASSED.
- 2024-09—To give the Local Lodges the opportunity to add or not add the Secretary and Treasurer to the Board of Directors. 1,892 YES, 567 NO. PASSED.
- 2024-10—To clarify and make uniform the standard of proof at trials before the Grand Forum resulting from any appeal of an Executive Order. 2,265 YES, 186 NO. PASSED.
- 2024-11—To clarify and make uniform the standard of proof at trials before the Grand Forum resulting from any appeal of an Executive Order. 2,247 YES, 203 NO. PASSED.
